A reading from the Acts of the Apostles

Philip went to a Samaritan town and proclaimed the Christ to them. The people united in welcoming the message Philip preached, either because they had heard of the miracles he worked or because they saw them for themselves. There were, for example, unclean spirits that came shrieking out of many who were possessed, and several paralytics and cripples were cured. As a result there was great rejoicing in that town.

gospel focus

Paraclete

parakiçtos, The Greek word, is translated into a number of different terms in English translations of the gospel. Its technical use was for a lawyer or attorney. However, its use in scripture is like the broader meaning of advocate that we use today: someone who stands up for another; someone who speaks up for another; someone who intercedes on behalf of another. An advocate is one who lends strength and support to someone who is disempowered. That is exactly what Jesus did for many people during his ministry and it is also what the Holy Spirit is sent to do.

EXPLORING THE WORD

Today's Gospel again alerts the disciples to that time when Jesus will no longer be with them. His departure will be a severe challenge to their faith, and Jesus gives voice to the challenge: 'If you love me you will keep my commandments.' This challenging call to follow the commandments of Jesus is accompanied by a gift - the gift of someone else, the advocate, who will be by their side during that interim period between the two comings. Jesus does promise to return, and in the meantime, his presence, and that of the Father, lives on in the love that is to be the way of life of the Christian. The Holy Spirit is not a thing apart from God and Jesus but the bond of love between them, and the believer is drawn into this love and becomes a part of it through living the way of Christ. Through the Spirit, Jesus remains forever present to the church, and all Christians are brought into the very life of God. Contemplate the ways you experience the life and love of the Spirit of God in the world:

- in nature and human relationships
- in society
- in personal prayer
- in the church and its liturgy

MAKING CONNECTIONS

Opportunities for discussion and personal prayer

- When have you felt abandoned or left behind?
- What, for you, are the key commandments of Jesus?
- Who have been those people who have helped you through difficult times?
- Recall an experience of being supported by someone in a time of critical need. Share your memories of what form that support took and the impact it had on you.
- Be 'life-giving' to someone this week. Be an advocate, a counsellor or comforter to someone in need.
- Pray to the Holy Spirit this week:

Come Holy Spirit, renew me with your gifts. Heal my brokenness, pour down your wisdom.

Instil your peace within me, inspire my every need.

Amen.

DID YOU KNOW?

- Some translations of the Bible use the word paraclete instead of advocate; others use the word counsellor or comforter.
- In John's Gospel, the Holy Spirit continues the work of Jesus himself (14:17, 26), recalling things the earthly Jesus taught or revealing things he was unable to convey. In John's view, this spiritual knowledge or insight, unavailable until after Jesus' death and resurrection, makes Christian faith and understanding fully possible

COVID-19 THINGS WE MUST STILL DO!

COVID-19 will be around until there is a vaccine, so keep social distancing wherever you are and whomever you are with. Keep hand washing/sanitising and avoid touching ones face.

Remember, that if you are showing any signs or have any symptoms of a cold or flu, stay isolated and schedule a visit to your Doctor. I'm sure no one of us wants to be responsible for carrying COVID - 19 to anyone, or receive it from anyone.

Some people have told me, they believe, these restrictions are an over-reaction, that COVID-19 is just like any virus. Unfortunately, they are very wrong!

300,000 deaths worldwide are testimony to that and more people are still dying!

If we disregard our own responsibilities in this pandemic, we could be a risk to others.

So, why I am reinforcing this? Because some restrictions have been lifted and we are now allowed to do some other activities but it is all DEPENDANT on <u>each one of us</u> doing the right thing.

Below I have copied what we as a Parish can now do. Based on our commitment as a Parish in doing these and what support I receive in organising, scheduling and monitoring - some activities may resume?

If there is not enough support now, then we may not be prepared for when further restrictions are eased in the coming weeks/months,

So please have a read, below. I will be meeting with the Parish pastoral Council this week to discuss implementing new measures. There will be temporary changes, which we must live with for the time being.

UDPDATE: GENERAL GUIDELINES COVID-19 Implications for the Catholic Archdiocese of Melbourne

In response to the recent announcement of changes to access for churches and places of worship, the Archbishop has approved the following guidelines for the Archdiocese of Melbourne. The guidelines aim to assist Clergy and Faithful with questions pertaining to specific areas of liturgy and ministry in the Archdiocese of Melbourne during this time of the COVID-19 pandemic.

Changes come in to effect as of 11.59pm, Tuesday 12 May 2020.

Four key points to note

In relation to the latest directives announced by Government, there are four key points that directly affect churches, places of worship and liturgical celebrations and ceremonies held within.

- 1. All churches and places of worship may be opened for pre-arranged worship, small religious ceremonies or scheduled private worship times, subject to a number of conditions and to the decision of their Pastor.
- 2. Multiple liturgical celebrations or ceremonies can be held on the same day and may be determined at the decision of the Pastor and by the capabilities of each individual Parish to meet all the required conditions.
- 3. Prayer groups can be held in people's homes (and in churches) subject to a number of conditions.

Baptisms, Weddings and Funerals can be celebrated with new changes to numbers of attendees, and again subject to a number of conditions.

In general, conditions require:

- No more than 10 attendees in the Church at any one time outside those required to enable the service. (Weddings and Funerals excepted);
- Clear signage around service schedules, social distancing and hygiene requirements;
- Availability of sanitiser and disinfectant wipes, and safe disposal sites;
- Churches to be cleaned after a scheduled service or opening;
- Maintenance of 1.5m of separation and planned entry and exit pathways;
- All attendees to provide contact details.

Note:

The four square metre rule, which limits the number of people who can be in a building, applies at all times. This is not about distancing between people (which is 1.5m) but is about building capacity. A space can only allow 1 person per 4 square metres. This pertains particularly to a Funeral, but possibly a Wedding or Baptism, where a larger number of attendees and those enabling the liturgy to run may be present.

Also, CONTACT DETAILS are required for all attendees at Masses or ceremonies – and must include: First Name + Contact Number + date and time at which the person attended the place of worship.

From the Archbishop's Office What can my Parish do?

Points to consider in determining in how your Parish might be able to move into new Stages of re-opening.

With churches being permitted to open for Masses and liturgies (under strict number and hygiene limitations), Parishes must clearly assess whether they have the resources available to move forward. Each Parish situation will differ as they determine their capabilities to meet the needs of their people in their own locality.

Please also consider maintaining your livestreaming where possible. This has been an important point of contact and spiritual resource for people, and will continue to assist the housebound, vulnerable and those who do not feel comfortable in returning to public spaces at the current time.

The major points for consideration are:

Ability to determine limited numbers – booking attendance:

- How will your parish determine the 10 permissible attendees;
- How will you capture the contact details required of every person that enters the building under the specific guidelines which require First Name + Contact Number + date and time at which the person attended the place of worship;
- How will you store and keep that information;
- Parishes will need to determine how they take in bookings for the 10 allocated attendees per Mass. This will be very difficult especially for larger communities;
- Some suggestions have been put forward: Use TryBooking or Calendly;
- As an example the booking for weekday Masses might open 9am-6pm the day before. By closing off the booking the night before, you or your team will know who to expect;
- All requirements regarding collecting names and details can be managed through a booking system like Trybooking or Calendly;

Pre-arranged/scheduled Masses and liturgies:

- The Archbishop will be issuing a decreed dispensation to allow Clergy to say extra Masses per day, until the end of May, to assist in providing further opportunities for the faithful to attend. This permission should only be exercised depending on local circumstances and capabilities to manage distancing and hygiene precautionary requirements. The faithful may only attend one Mass per day.
- Smaller Parishes who can accommodate their faithful easily may wish to be in conversation with neighbouring larger parishes to see how they can support their communities;
- Scheduling extra Masses needs to be carefully worked out to meet the hour cleaning gap between liturgical celebrations— and allowing windows for weekday funerals;

2 Liturgical options:

You may wish to consider the following as options for the faithful to attend:

- Adoration of the Blessed Sacrament perhaps held in conjunction with Confession and with monitored time-limits for those present (meeting the 10 people per attendance) and maintaining an hour space between other ceremonies to enable cleaning of all pews and other surfaces;
- First Rite of Reconciliation;
- Liturgy of the Word

Individual Private Prayer:

- Churches may be opened for scheduled times of Individual Private Prayer. Only 10 members of the public may be present, in addition person/s reasonably required to conduct the space may also be present. All distancing and hygiene measures must be in place including floor and outdoor signage to prevent people congregating or waiting in queues.
- Making Private Prayer available will require door monitoring to check how many people are present at any one time, and communicating a workable and nominal length of time that people should spend in prayer (to allow others the opportunity to partake).
- Contact details must be taken as per regulations: First Name, contact number, time in attendance.

Hygiene precautionary measures - resources and capability to monitor and guide worship behaviours:

- Clear and frequent signage must be visible at all times and should include the limit of permissible numbers in attendance, social distancing reminders, hygiene, where people can sit, how they enter and exit the building, and where they may wait for communion etc.
- An attendance register needs to record: first name. contact number, date and time of attendance (this is to ensure contact can be tracked).
- Opening a venue requires attention to detail to prevent people gathering closely and avoiding face-to-face confrontation of less than 1.5m. (3m if they are singing). Marking of distance in aisles and seating points in pews. (households can sit together but all others must be spaced);
- There is a need to sanitise all touchpoints between liturgical celebrations. This means disinfectant wiping of door handles, hand rails, light switches, Lectionary, Missal, Cruets, Sacred Vessels, pens and attendance register, top and front edges of seats or pews. Between every celebration;
- At least 60 mins space between liturgical celebrations to enable cleaning and to ensure the next group don't run into the last group;
- Collection plates cannot be passed. (suggest collection baskets on a table and people approach (suitably distanced) and return to their seat as would be done for communion);
- One only entry and separate exits, with traffic flow clearly defined. Clear arrows on floor denoting direction of travel. Markings stating no entry at the exits and no exit at the entrance. Opportunity for hand sanitising if possible;
- All Parishes should purchase a Sneeze-Guard (as seen in retail outlets) to provide hygiene protection in Confessionals;
- No hymn books but bulletins would be fine if they are 'one use.' Signage must clearly indicate that they should be taken home;
- Must be highly visible sanitising stations and disposal areas, and a monitored supply of sanitising supplies.

So are you all very confused yet?

Let me summarise and share with you some simple steps that have already been done and must be done before we consider anything.

What are we at St Macartan's planning to do?

Hello everyone,

Yes it is a good sign that we can now start to look at getting back to worshipping together, hence, be it in a different way a - New Normal, people are saying.

These are things I have already put in place:



- Every second pew has got barrier tape preventing any use.
- All pews can only have three (3) adults per pew, seated one in middle and one either end (excluding children).
- To fit within the 4sq metre rule per person. I have calculated the area of both ground floor sitting areas. Our church, in total, can accommodate up to 100 people.
- The upstairs sitting area of the Church will be <u>off-limits</u>.
- There will be only One door open to ENTER the Church and One separate door open to EXIT the Church. There will be signage in place.
- Tables will be at all doors with hand sanitiser bottles, where everyone who enters and leaves must use.
- Extra hand sanitizers has been purchased.
- Surface disinfectant is to be used on all contact surfaces in the Church after each event by assigned volunteers.
- Two attendance counting machines have been purchased.
- There will be sign-in books at the entrance door where everybody who enters the church must fill in their contact details (no exceptions). Volunteers will be at the door to ensure people sign in, use the sanitising stations and are counted in.
- Hand sanitisation stations and sign-in books will also be set-up in the Community House and Hall.
- Church cleaning and sanitizing will be increased.
- No Masses or any events are scheduled to begin until I have met with the Parish Council and have teams available to Monitor, control and support every activity. I am meeting with the Parish Council this week.

So for now - Nothing will change, but by next week I hope to have better news.


